

COMPREHENSIVE GENERAL LIABILITY INSURANCE - 4

<u>NAMED INSURED:</u>	Rugby Canada, its Provincial Unions, Clubs, Members, Officials, Directors, Employees, and Volunteers.
<u>OBJECT OF INSURANCE:</u>	Comprehensive general liability covering the Insureds legal liabilities to third parties for death, disease, bodily injury, personal injury and/or loss, damage or loss of use of property.
<u>EXTENTIONS FOR PREMISES:</u>	The premium exposure includes the Rugby National Office, Provincial Union Offices, All sanctioned events including practices and play
<u>LIMITS OF LIABILITY:</u>	\$5,000,000 each accident or occurrence for Bodily Injury and Personal Injury Liability and Property Damage Liability
<u>DEDUCTIBLE:</u>	\$ 1,000 per occurrence on property damage \$ 1,000 per occurrence on bodily injury
